



Application for Squadron Charter SONS OF THE AMERICAN LEGION

(Must be sent through Department Headquarters)

ARTICLE IV Eligibility

Section 1. All male descendants, adopted sons, and stepsons of members of The American Legion, and such male descendants of veterans who died in service during World War I, or December 7, 1941, to date, as set forth in Article IV, Section 1, of the National Constitution of The American Legion, or who died subsequent to their honorable discharge from such service, shall be eligible for membership in the Sons of The American Legion.

Section 2. There shall be no form or class of membership except an active membership.

ARTICLE IX Squadron Organization

Section 1. Those who desire to form a Squadron the Sons of The American Legion shall make application for a charter to the Post Commander of the local Post of The American Legion in the area in which they reside. Upon approval by the Post Commander the application shall be forwarded to the Department Commander of The American Legion, and upon his approval it shall be forwarded to the National Headquarters of The American Legion, where the charter may be issued by the National Commander and the National Adjutant of The American Legion in the same manner as prescribed for the issuance of charters for Posts of The American Legion.

Section 2. The minimum membership for the formation of a Squadron of the Sons of The American Legion shall be (ten) 10.

Section 3. There shall be no more than one Squadron of the Sons of The American Legion for each Post of The American Legion. Squadrons may be organized into sections based upon age.

(The Sons of The American Legion shall be organized under the jurisdiction of the local post of The American Legion and shall bear the name and number of the Post.)

INSTRUCTIONS: (please read carefully) – Each local group will designate a representative/organizer to print and sign at the footer section at the bottom of this application and to receive the charter when issued. Applications should be properly executed by a minimum of (ten) 10. Upon approval by the post commander, the application shall then be forwarded to the Department Headquarters for review. Once reviewed the Department shall then forward application to National Headquarters for processing.
